1.0 Apologies

2.0 Minutes of the previous meeting in Tenerife.

These were accepted as a true record.

3.0 Matters Arising.

Abstracts from previous IPS meetings (incl 2010) have now been put on-line at the IPS web site.

Perimetric standards document has been put on-line (Pam Sample).

Perimetric standard document has been published in a feature issue of Optometry & Vision Sciences (Chris Johnson).

No action has been taken with regard to imaging standards but Linda Zangwill has agreed to lead group that will include Mitch Dul.

First part (1 of 3) of German CME document on how to conduct a visual field test is now on-line. There was encouragement for the other 2 parts to be translated and placed on-line (Fritz Dannheim, Paul Artes).

4.0 Secretary's Report.

David Henson presented the Secretary's Report. Membership at date of Melbourne meeting: **144** (down from 150 in Tenerife 2010, see attached table).

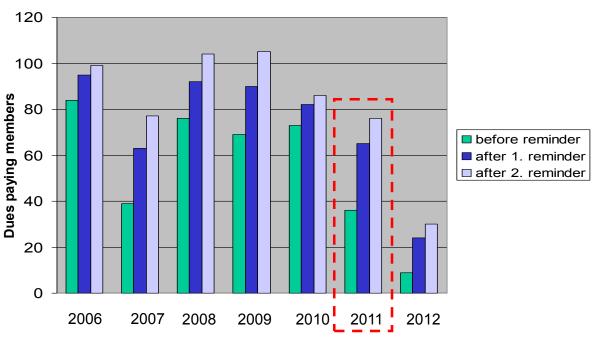

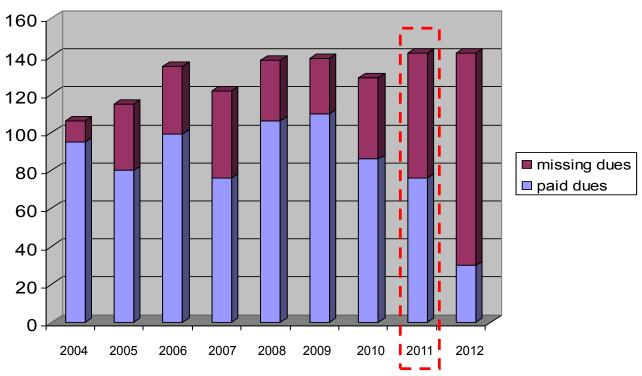

Ulrich Schiefer is stepping down as treasurer. Problems with the transfer of monies and the management of German bank accounts were the major reasons for his decision. It would be ideal if the new treasurer were to be in the USA.

6.0 IPS membership of presenting authors.

At the last Board meeting it was agreed that the presenting author of papers and posters at IPS Symposiums should be a member of the IPS. Unfortunately, this was not stated on the Abstract submission forms (which were copied from the 2010 meeting) and we ended up with several presentations being given by non-members. After much discussion it was agreed that the presenting author should be a member and that for future meetings this should be made clear on the Abstract submission form and that a simpler process should be introduced for becoming a member that will be part of the Abstract submission process.

7.0 Heidelberg award

Three applications were received this year. Decision on the award will be made at the end of the meeting (after all presentations have been given). The decision will be made by the Heidelberg award committee (Fritz Dannheim, Paul Artes, Linda Zangwill and Ron Harwerth).

8.0 Opportunity Fund.

Chris Johnson reported that registration of a formal fund, which would allow for tax deductable donations, is very costly and beyond the budget of the IPS. CJ suggested that there should be 3 independent (but not formal) funds, one based in the USA, one in Europe and one in Asia/Australia. There was a discussion of how the funds

should be used with proposals for it to provide grants for young researchers (MW) and support for technicians (US). Mitch Dul had wide support for his proposal that it should be an endowment fund although there was concern related to whether the fund would ever be large enough to provide significant returns. Discussion ended with recognition that somebody needs to take this forward. CJ agreed to approach David Garway-Heath.

9.0 Visibility of the IPS

It was agreed that the President would contact the WOC to see if the IPS could be added to its list of Supporting Organisations.

10.0 Travel Awards

There was some confusion over the eligibility for this award. Paul Artes will produce a revised set of eligibility criteria that will be used for subsequent meetings. The award will be extended to those with short-term post-doctoral positions. The number and value of the awards for the next meeting to be decided.

11.0 Election of new Secretary

David and Patrice Henson were thanked for all their work since becoming IPS sec

David Garway-Heath was nominated and received the support of the Board. His nomination will be put to the membership at the IPS Business Meeting.

12.0 Election of new Treasurer

Ulrich Schiefer was thanked for all the work he has done while treasurer of the IPS.

Chris Johnson proposed Mitch Dul to be the new treasurer who received the support of the Board. His nomination will be put to the membership at the IPS Business Meeting.

13.0 Venue of next IPS meeting 2014

Mitch Dul has agreed to host the next IPS meeting in New York on the 10-14th September 2014.

Future meetings of the IPS 2016/2018.

The 2016 meeting will be in Northern Italy, host Paolo Brusini and Mark Zeppieri. It is likely to be in June 2016. Exact location is subject to expected size and availability of venues. Decisions on the 2018 meeting are pending further discussion. It was felt that 2018 should be outside Europe (possibly Toronto Canada, John Flanagan) and that the 2020 meeting would be in Switzerland (Mario Zulauf).

14.0 Consensus on progression criteria

Ulrich Schiefer had received a request by Tunde Peto, Centre for Ophthalmology, at Moorfields Eye Hospital, Head of Reading Centre, for the IPS to produce "well defined, stand-alone, validated and reliable progression measurements". The Board felt that this was not possible at the present time but that progress was being made as evidenced by the number of presentations on this topic at the 2012 meeting. The Board suggested to invite Tunde Peto to join the IPS in order to bring this issue forward.

15.0 Open Perimetry Initiative

Paul Artes updated the Board on the availability on progress towards allowing external control of the Octopus 900 perimeter. This is likely to become available in the next few weeks and will allow researchers to independently control stimulus parameters. Similar facilities are expected with the Heidelberg Edge perimeter in the near future and the Board hopes that all perimeters will provide such facilities in the future.

16.0 Japan Perimetric Society.

Chota Matsumoto updated the Board on the progress that had been made in setting up this society highlighting its links to the IPS. It was agreed that, in future, the presenting author should be a member of the IPS.

17.0 AOB

There was no further business.
